Bailiff fees are fixed in law, so the bailiff can ' t charge you more than the standard amounts. This means that the bailiff can't keep adding more and more fees. However older debts, where bailiffs got involved before April 2014 have different fees, and these may be higher.

You can find the bailiff ' s contact details in any letters they ' ve sent you about the debt. Calling them is the quickest way to get in touch. It ' s best to pay by bank card or by cheque so you have a record. Also ask the bailiffs to send you a receipt when you pay - it ' s important to get this in case you later need to prove you ' ve paid.
