You can apply to retake the exam at your earliest convenience. Fees. The fee for the Florida Chiropractic Laws and Rules Exam (FCLR) is \$95. If you receive a failing score on FCLR, the retake fee is \$95.

Initial Licensure Biennium: All chiropractic physicians initially licensed within the biennium are exempt from the CE requirements for renewal with the exception of: 1) Within the first 12 months, one full day at a Florida Board of Chiropractic Medicine meeting at which disciplinary hearings are conducted as provided in subsection 6482-13.004(8), F.A.C. (NOTE: Initial licensure practitioners who reside out of the state may satisfy this requirement within 12 months after locating to the State ...
